"Typical" snow storm

- Starts as freezing rain or snow
- Pavement temps usually 20+ degrees
- Average 1-4 inches
- Timing of storm can create issue major roads
- Wrap up 12-24 hours after storm ends

Case Study

West Des Moines, IA – "Snow Storm From Hell"







Storm from Hell

- "Waffling forecast"
- Cold Pavement Temperatures (19 degrees) then rapidly warming air temperature
- Started out as rain 1:00PM
- Turned to heavy snow 2:00PM
- Regional traffic nightmare

"More"

- 8-10 inches of heavy/wet snow
- Crews focused on major streets
- Residential streets got packed down
- Weather then turned very cold
- The storm was over the "fun" started!

Case Study

Denver – Residential Street Nightmare

"Blizzardpalooza"





"Nightmare" Events

- Heavy Snowfall Event; 20"+ Dec 20, 20"+ Dec 28
- Followed up my more events
- Cold air/pavement temperatures
- Typically did not plow residential streets
- Streets became extremely rutted

Nightmare "Cont."

- Massive outcry from the public
- Media feeding frenzy
- Forced staff to improvise
- Started cutting snow and ice



- Normal winter expenditure ~\$5M, this event ~\$13M
- 4 years damage to pavements

Things to Consider!

- Your typical level of service expectations
- Your current plan for extraordinary events
- Non-typical storm event stayed very cold for days
- More than one storm close together
- How would you handle the negative press and citizen complaints
- How will you elected officials react?





Operational and Policy Changes

- No pre-treatment due to rain deicer products would not really have helped
- Utilize sand for areas that need traction when deicers are ineffective
- Pre-position equipment for faster response time
- Looked at ice breakers not really feasible for our agency?
- Try and move to lower volume streets to plow since major roads were highly congested
- Get contact agreements in place to have availability for motor graders to cut packed snow/ice
- Be more pro-active with public relations. Partner with our County Emergency Manager and other regional agencies to send out a uniform message. More of an emergency management approach.
